All participants of the CBKT programme (lecturers, trainees, secondees and others) are required to read this information, and by accepting the invitation to a CBKT initiative, accept the conditions laid out in this document.

COPYRIGHT INFORMATION

The BIPM respects the intellectual property rights of authors whose materials are presented at the CBKT initiatives.

Copyright applies to all CBKT programme materials including presentations, lecturing materials, brochures, publications and other documents. Even if electronic versions are available free of charge on the BIPM CBKT web-page (also restricted access page), economic and moral rights¹ related to the presented materials are protected in accordance with the copyright law of the author's country.

All CBKT programme materials are only for non-commercial use.

INFORMATION TO LECTURERS:

By giving a lecture at the CBKT programme events lecturers agree that their materials will be uploaded into the BIPM restricted access CBKT resources page and used for any CBKT initiatives conducted by the BIPM. The access to the page will be given only to participants. Lecturers also grant permissions to the BIPM to transfer the materials to be presented for further non-commercial training purposes among the metrology community. ¹ There are two types of rights under copyrights: economic and moral rights. Economic rights allow the owner to derive financial reward from the use of his works by others. Moral rights allow the author to claim authorship and the right to object to any distortion that would be prejudicial to the author's honour or reputation.
